Broadly speaking, a risk assessment is the combination effort of 1. identifying and analyzing potential (future) events that may negatively impact individuals, assets, and/or the environment (i.e., risk analysis); and 2. making judgements "on the tolerability of the risk on the basis of a risk analysis" while considering influencing factors (i.e., risk evaluation).
